My sad conclusion is that this recording may well be from a mental hospital, possibly from recording a COINTELPRO actively tormented (or tortured) brain waves while he or she was locked up in a mental hospital.

Ed The April 30-July 30, 2005 version of ~~the~~ FBI COINTELPRO electronic warfare is I believe the 3rd significant version of FBI electronic warfare that I recall at this point in time in my life. (I might have heard the term "transponder beacon" before April 30, 2005, but I'm not sure.)

The ~~most~~ early attacks were devices and at times worms. From April 30-May 14, 2005, COINTELPRO pretended to be an electronic mental hospital. I was ordered to flee around May 3 (7am one day around May 1) and <sup>simultaneously</sup> hit with a very human repellent pulse beam attack. I stayed.

From approx. May 3-5 I was dosed 2 weeks in a row, maybe by Robin Wynn. <sup>I suspect but can't prove [it]</sup> and subjected to various mind control attacks by Jay Bendelton, who used terms like "wishes to his will and orders" "brows and eyes". He admitted that he was told that I would be dosed in preparation for the mind control attack. I was initially told to flee during this attack, but I did not. I curiously avoided being hospitalized, came down from 2 doses of a powerful mind-control drug, <sup>that left me very open and vulnerable</sup> and recovered.

At on May 27, Jay Bendelton, Jr, FBI SJD under 609 demanded all of my notes. ~~It was not~~ It was not new been for a promised end to the investigation. At this point I firmly concluded that my electronic attacks were indeed FBI COINTELPRO, now the FBI Special ~~Investigation~~ Division, FBI SJD.

Some of this is recorded in my Sat, June 4, 2005 notes.

 I have a (possibly very slanted, FBI subtitled) tape recording  
 recording of him yelling, he back in my room. He also

In May and June I tried to make electronic recordings

numbered ~~the~~ <sup>my</sup> pages after the probable removal of one or

On 6/12/04, I released ER373, a website  
posting documenting a 6-week COINTELPRO electronic

After the website release, <sup>FBI</sup> COINTELPRO tactics  
shifted to prevent all-night sleep deprivation attacks  
conducted on 6/15/05, 6/17/05, and 6/19/05, and <sup>heavy</sup> ~~heavy~~  
pulse bombing and routine ~~at~~ partial sleep deprivation  
attacks (and sometimes sleepiness attacks using FBI  
subliminals during the day).

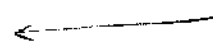
