I was ordered to flee around May 2 (I am <sup>simultaneously</sup> already around May 1) and that after spraying human repellent pulse beams attack. I stayed.

From approx. May 3-5, I was dosed 2 shots in a row, maybe by Robin Wren. [I suspect but <sup>haven't</sup> proven that] and subjected to ~~use~~ a vicious mind-control attack by Jay Pendleton, who used terms like "grind" to his will and orders, "break and crawl". He demanded that he was told that I would be dosed in preparation for the mind control attack. I was initially told to flee during this attack, but I did not. I believe that one or more pages documenting these death threats may have been accidentally removed by someone [possibly Robin Warren but this is unconfirmed <sup>and unproven</sup> speculation]. There were only 97 pages left in that log book at the end and thus should have been 100 pages and I numbered my pages after the probable removal of one or more blank pages of notes.

On 6/12/04, I released ER373, a new website posting documenting a 6-week COUNTDOWN election strategy stage.
